In addition, and to the fullest extent allowed by law, I agree that I will not institute any lawsuit or other legal action against the Club, its officers, directors, delegates, committee chairpersons, committee members, instructors, agents, representatives, servants, or assigns as a result of my participation or injury at any Club related activity, unless due to gross negligence or intentional acts of the Club; nor will I institute any lawsuit or other legal action against Club members as a result of my participation or injury at any Club-related activity, unless due to gross negligence or intentional acts of the member(s), nor will I voluntarily assist anyone else in the pursuit of any such lawsuit or other legal action.

I also agree to release the Club, its officers, directors, delegates, committee chairpersons, committee members, instructors, agents, representatives, servants, and assigns from any and all liability, claims, actions, suits, judgment, damages, and costs that may result by reason of my participation in or injury from any Club related activity, unless due to gross neg-ligence or intentional acts of the Club. I further agree to release Club members from any and all liability, claims actions, suits, judgment, damages and costs that may result by reason of my participation in or injury from any Club-related activi-ty, unless due to gross negligence or intentional acts of the member(s). This Release shall bind me, my distributes, heirs, executors, representatives, successors and assigns.

I understand and acknowledge that the Club is acting in reliance upon agreements made by me in this Release in order to extend to me the benefits of membership in the Club and that, were I not willing to abide by the terms of this document, such membership and opportunity to participate in Club-related activities would not be extended to me.
