

**GENERAL RELEASE OF LIABILITY FORM TRAILSWEEPERS SNOW AND SPORTS CLUB GENERAL
RELEASE PLEASE READ CAREFULLY**

I understand that the Trailsweepers Snow and Sports Club, Inc. (hereafter the "Club") is a year-round skiing, sports and social club, which sponsors a variety of activities, including skiing, ski racing, ski instruction, camping, canoeing, softball, and other sports and social events. I am aware that many of the Club's activities, including skiing, ski racing and ski instruction, are inherently dangerous activities, which involve the risk of serious injury or even death. I understand that the Club is a non-profit organization and that its members, officers, directors, delegates, committee chairpersons, committee members and instructors serve only in the capacity of volunteers. I agree that by participating in any Club-related activity, I am responsible for my own safety and agree that I knowingly and voluntarily assume the risks involved in any such activity. I agree that prior to participating, I will inspect any facilities and equipment to be used, and if I believe anything is unsafe, I will immediately advise a club officer of such condition(s) and refuse to participate.

In addition, and to the fullest extent allowed by law, I agree that I will not institute any lawsuit or other legal action against the Club, its officers, directors, delegates, committee chairpersons, committee members, instructors, agents, representatives, servants, or assigns as a result of my participation or injury at any Club related activity, unless due to gross negligence or intentional acts of the Club; nor will I institute any lawsuit or other legal action against Club members as a result of my participation or injury at any Club-related activity, unless due to gross negligence or intentional acts of the member(s), nor will I voluntarily assist anyone else in the pursuit of any such lawsuit or other legal action.

I also agree to release the Club, its officers, directors, delegates, committee chairpersons, committee members, instructors, agents, representatives, servants, and assigns from any and all liability, claims, actions, suits, judgment, damages, and costs that may result by reason of my participation in or injury from any Club related activity, unless due to gross negligence or intentional acts of the Club. I further agree to release Club members from any and all liability, claims actions, suits, judgment, damages and costs that may result by reason of my participation in or injury from any Club-related activity, unless due to gross negligence or intentional acts of the member(s). This Release shall bind me, my distributes, heirs, executors, representatives, successors and assigns.

I understand and acknowledge that the Club is acting in reliance upon agreements made by me in this Release in order to extend to me the benefits of membership in the Club and that, were I not willing to abide by the terms of this document, such membership and opportunity to participate in Club-related activities would not be extended to me. I further understand and acknowledge that Club-related activities would not be extended to me. I further understand and acknowledge that Club members are acting in reliance upon agreements made by me in this Release in volunteering their services and, in some instances, their homes and that, were I not willing to abide by the terms of this document, their services and homes would not be extended to me.

Code of Conduct

I understand camaraderie among the members is a crucial component of the Club's purpose and enhances the enjoyment of club activities by everyone. My conduct as a club member impacts the public's view of our club and the willingness of organizations to co-sponsor activities with our club. As a result I agree to the following:

- a) I will exhibit courtesy, good behavior and show respect for fellow members and other parties while on any club trip or while involved in any club-sponsored activity.
- b) I understand that offensive conduct, making threats, sexual harassment and intimidating behavior is not acceptable and will not be tolerated.
- c) I will obey all federal, state and local laws while participating in club functions and the rules and authorities of establishments where functions are held.
- d) I will support and promote safety at all club-sponsored functions.

I understand and accept that violations of this "Code of Conduct" can result in disciplinary action up to and including termination of membership.
