

AFFIDAVIT FOR TRANSFER OF TITLE TO A MOTOR VEHICLE

Less than \$25,000 pursuant to N.R.S. 146.080,
or \$100,000 as a surviving spouse

Pursuant to NRS 146.080, estates not exceeding \$25,000 or \$100,000 as a surviving spouse may transfer assets of an estate without issuance of letters of administration or probate of a will when an affidavit is provided, showing rights of the affiant or affiant's right to receive money or property or to have evidence transferred.

_____, being first duly sworn, upon oath says: that he/she is the spouse, child, lawful issue of deceased children, the parent, brother, sister, sole beneficiary under Last Will and Testament, or a minor, or an insane or incompetent person bearing that relationship to decedent, of _____, deceased, who died in the County of _____, State of Nevada, (or wherever death occurred) on the _____ day of _____, 20_____.

Being a resident of the State of Nevada, died, leaving no real property or interest therein, nor a lien thereon, situated in the State of Nevada;

- That the total value of the decedent's property, situated in the State of Nevada, does not exceed Twenty Five Thousand Dollars (\$25,000), excluding amounts due decedent for services in the armed forces, and that the property does not include any real property nor interest therein or lien thereon;
- If the transfer is to a surviving spouse, the estate value must not exceed \$100,000;
- That no application or petition for the appointment of a personal representative is pending or has been granted in any jurisdiction;
- That all debts of decedent, including funeral and burial expenses, have been paid or provided for;
- That no funds are owed to the Nevada Department of Health & Human Services, (Nevada State Welfare);
- That the Affiant has given written notice by personal service or by certified mail, identifying his claim and describing the property claimed, to every person whose right to succeed to the decedent's property is equal or superior to that of the Affiant and at least 14 days have elapsed since the notice was served or mailed; and
- That the Affiant is personally entitled to full payment or delivery of the property claimed or is entitled to payment or delivery on behalf of and with written authority of all other successors who have an interest in the property.
