Frisco Roofing is only liable for the roof. If there is leakage or any condition caused after the roof repair has been completed and inspected, which is inherent to the condition of the structure itself, Frisco Roofing is not liable for such leakage or condition. If however, property owner's insurance company does not approve of all of the work proposed herein and benefits are not payable for all said work, the contract is null and void.
