Scope of Work

Contractor shall provide the Services and Deliverable(s) as follows:

Deliverable Materials

Contractor Responsibilities

Contractor shall provide 100 Wonder Widgets and the services of 1 Widget Engineer for 40 hours of labor.

Client Responsibilities

Client shall provide the Widget Engineer access to the resources required to facilitate the installation of the 100 Wonder Widgets by the Client.

Payment Schedule

Services shall be conducted on a Time & Materials basis. The total value for the Services pursuant to this SOW shall not exceed \$100,000 unless otherwise agreed to by both parties via the project change control procedure. A PCR will be issued specifying the amended value.

Services shall be performed on 40 hours of professional services. Contractor will provide up to 101 resources based on the resource structure.
