Ex-Dividend vs. Record Date

Ex-Dividend Date

The day a stock trades without the benefit of the next scheduled dividend payment. This is the day before the trade's record date.

Record Date

Finalizes the transfer of the stock's ownership. Only investors who own stock on this date receive the dividend.
