

SAMPLE VISITATION SCHEDULE*

The (Father/Mother) shall be entitled to exercise reasonable visitation with the minor child(ren) with the following provisions effective _____.

- A. On every other Friday at 6:00 p.m. until the following Sunday at 6:00 p.m.; OR
1st, 3rd & 5th Weekends from Friday at 6:00 p.m. until the following Sunday at 6:00 p.m.;
- B. During ODD numbered years (2007, 2009, etc.) the Father shall be with the child(ren) on the holidays as follows:
1. Martin Luther King's Birthday
 2. Memorial Day
 3. Labor Day
 4. Thanksgiving, from 6:00 p.m. the Wednesday before until 6:00 p.m. the Sunday after.
 5. Second week of Christmas vacation from 2:00 p.m. on December 26th, until 6:00 p.m. on New Year's Eve;
- C. During EVEN number years (2006, 2008, etc.) the Father shall be with the child(ren) on the holidays as follows:
1. New Year's Day
 2. Easter or Spring Break
 3. July 4th
 4. Halloween
 5. First part of Christmas vacation, including Christmas Day from 6:00 p.m. the last day of school until 2:00 p.m. on December 26th.
- D. During ODD number years (2007, 2009, etc.) the Mother shall be with the child(ren) on the holidays as follows:
1. New Year's Day
 2. Easter or Spring Break
 3. July 4th
 4. Halloween
 5. First part of Christmas vacation, including Christmas Day from 6:00 p.m. the last day of school until 2:00 p.m. on December 26th.
- E. During EVEN numbered years (2006, 2008, etc.) the Mother shall be with the child(ren) on the holidays as follows:
1. Martin Luther King's Birthday
 2. Memorial Day
 3. Labor Day
 4. Thanksgiving, from 6:00 p.m. the Wednesday before until 6:00 p.m. the Sunday after.
 5. Second week of Christmas vacation from 2:00 p.m. on December 26th, until 6:00 p.m. on New Year's Eve;
- F. The children will be with the MOTHER on Mother's Day;
- G. The children will be with the FATHER on Father's Day;
- H. The (Father / Mother) will have two consecutive weeks to be with the children in the summer from June 1st until August 1st provided the children are not in school. During this period, the (Mother/ Father) can have the child(ren) on the weekend directly between the two weeks from 6:00 p.m. Friday until 6:00 p.m. on Sunday. The (Father / Mother) agrees to give the other parent a minimum of 30 days written notice of his / her) intent to exercise the summer vacation;
- I. Holidays shall take precedent over weekend visitation;
