

Annualized Rate of Return Formula

$$\text{Annualized Rate of Return} = \left[\frac{\text{Initial Value} + \text{Gains or Losses}}{\text{Initial Value}} \right]^{\left(\frac{1}{\text{Holding Period}} \right) - 1}$$
